Summary of the candidate's restorative justice background and their (envisaged) contribution to the EFRJ:

I worked in the Probation Service in Northern Ireland for 25 Years. I was then an independent consultant and trainer until I was appointed by Ulster University to direct the Masters in Restorative Practices. Through this I trained hundreds of people in restorative practices and conducted several substantial research studies into restorative justice. I have published widely in this field. In 2016 I became a visiting lecturer at Ulster University allowing me more time to devote to the EFRJ.

I have been a member of the EFRJ since 2006 and a member of the Board since 2012. I became Chair of the Board in 2016. In the past year I have visited Germany, Belgium, Italy, Croatia, The Netherlands, Ireland, the Basque Country, Scotland, Spain, England and Bosnia Herzegovina to speak at conferences and to offer training and consultancy.

My priority is supporting the transition (Forum 15) that the EFRJ is going through so that it can become more proactive and effective promoting restorative justice in Europe, expanding its scope and developing the quality of restorative practice and research. I believe that the change process will take another two years.

Comments made by proposer:

Tim Chapman is an excellent chair of the EFRJ. He is a restorative justice expert from the first hour. He knows much about practice, but also has the academic perspective. His senior voice is charismatic. He likes to share his RJ knowledge and the stories of people. Above all he is a very warm leader who inspires many practitioners in Europe and beyond. Under his guidance the Forum has started a new period with more involvement of the members that we would like continue. In my position as the vice chair and on a personal level I really like working with Tim, who is a good team player, listens well and takes decisions when needed. <u>Summary of the candidate's restorative justice background and their (envisaged) contribution to</u> the EFRJ:

I have twenty years of progressively responsible experience working on justice reform initiatives that have strengthened the rule of law in my native country of Georgia. For the past ten years, my professional efforts have been focused primarily on liberalizing Georgian criminal justice policies and strengthening capacities of Georgian criminal justice institutions. During that time, I have both witnessed and compared different outcomes of zero tolerance and harsh criminal justice policies and application of restorative justice approaches. Working with strong, committed teams of professionals under European Union-funded Projects, I have collaborated on the creation of rehabilitation and resocialization mechanisms within the Georgian probation and penitentiary systems, for adults as well as for juvenile defendants and convicts, and I have further helped to implement juvenile justice reforms in accordance with the comprehensive juvenile justice strategy designed and approved by the Criminal Justice Inter-Agency Coordination Council of Georgia. These aforementioned reforms established a vital underpinning for our introduction of diversion and mediation programs within recent years and, ultimately, culminated with recent adoption of a Georgian Juvenile Justice Code in line with the United Nations Convention on the Rights of the Child and the UNODC Model Law on Child Victims and Witnesses of Crime.

Our purpose in promoting restorative justice practices in Georgia has been to advance the best interests of the child by eliminating discrimination, by ensuring each child's right to be heard, by protecting the privacy right of juveniles, by safeguarding the right to a fair trial, by eradicating criminal stigmatization, and by resorting to imprisonment only as the last measure. As the result of our successful reform efforts over the years, Georgia now adheres to the principle of minimal intervention while providing maximum support for alternative measures to criminal prosecution, both for the protection of child victims and for application of similar standards before "young offenders".

We in Georgia are extremely encouraged by our own evidence-based success in juvenile justice. Our juvenile justice system today stands in marked contrast to where it stood a mere few years ago, when we could only refer to the best practices of Europe and other developed countries. Thanks to the solid partnership between the Georgian Government and civil society, we can now take pride in significant legislative, institutional and practical results which Georgia has realized in protecting and strengthening the rights of juveniles. In promoting restorative justice in my

country, I have witnessed first-hand this remarkable transformation. I have seen how individuals can be reintegrated back into the society; I have seen how victims of crimes can become the best defence against repeat offenders if their voices are heard; I have seen Georgians find a measure of peace through restorative justice processes; and, finally, I have seen the difference between isolation and rehabilitation. This transformation instils deep confidence that restorative justice is our surest path to prevent recidivism and to ensure a safer society.

For all of these reasons, I am excited and eager to continue advocating for the promotion and expansion of restorative justice in my country, as well as elsewhere. Most especially, our success in Georgia provides strong motivation for my application for membership on the Executive Board of the European Forum for Restorative Justice. If entrusted with this responsibility, I will concentrate my efforts and utilize my skills and knowledge to promote restorative justice throughout the region. Having already completed consultancies in Ukraine and Armenia aimed at developing restorative justice approaches for children in conflict with the law, I am fully cognizant that a lot more remains to be done throughout the entire region. I strongly believe that even a small group of motivated people who believe in change can bring about big changes. I speak from that experience: I have collaborated successfully with many extremely knowledgeable and experienced national and international experts – professors and practitioners; I have organized various highlevel international justice-sector conferences, trainings and workshops; I have completed consultancies on sector management and coordination within state institutions, with civil society and for donors; and I have designed projects and raised funds as founder and director of the NGO/FUND "New Page" created to help children in conflict with the law. I am confident that I possess the requisite skills, experience and motivation to contribute substantively and substantially to the mission of the European Forum for Restorative Justice as a Member of its Executive Board, and I am eager to dedicate my time to promoting restorative justice through various supporting EFRJ activities.

Comments made by proposer:

It gives me pleasure to propose Ms. Maia Chochua as Member of the Executive Board of the European Forum for Restorative Justice. Ms. Chochua is a lawyer from Georgia with a master degree in public administration who has been involved in reforming the criminal justice system in her home country for the past 20 years. After the Georgian revolution she has contributed to the implementation of the Criminal Legislation Reform Strategy, and played a key role in the development of juvenile diversion through the mediation program in Georgia. She is not only an active promoter of restorative justice approaches in her home country, but also in neighbouring Ukraine and Armenia where she has provided expertise on reforming their juvenile justice systems, drafting juvenile justice codes and building multi-disciplinary cooperation.

Coming from an Eastern European country myself, I know that reforming criminal justice systems can be challenging processes that take years, but more than that they require commitment at different society levels. For this reason alone, I believe that Ms. Chocua's results in this sector speak for themselves; having her on the Executive Board will provide the EFRJ with a strategic connection to this European region.

Comments made by seconder:

I want to act as a seconder to the proposal to elect Ms. Maia Chochua, a lawyer from Georgia as a member of the Executive Board of the European Forum for Restorative Justice. Ms. Chochua has been active for about twenty years in criminal justice reform in Georgia, contributing to the drafting of new legislation, of setting up training and monitoring of training - predominantly in the field of juvenile justice. Presently she is involved in promoting the extension of restorative justice to adult criminal justice. She has also contributed to promoting restorative justice in the region by providing expertise to Ukraine and Armenia on reforming juvenile justice systems.

I myself have seen the dedication and commitment of young lawyers and social workers in Georgia in the course of participating and delivering a speech in a conference in Tbilisi in 2011. Georgia appears as a place of hope for spreading the idea of restorative justice to the countries of these region. Deepening Maia's connection by including her in the Executive Board of the EFRJ would therefore be highly advisable and would benefit both Georgia and the EFRJ.

Summary of the candidate's restorative justice background and their (envisaged) contribution to the EFRJ:

Rasim Gjoka is the Director of the Albanian Foundation for Conflict Resolution and Reconciliation of Disputes (AFCR). AFCR is the leading civil society organization in the area of Alternative Dispute Resolution and Restorative Justice in Albania, with 23 years of experience. Since the year 2000, the organization has been implementing projects on restorative justice, with a focus on juvenile victims and offenders, which were initiated in cooperation and support from the Norwegian Mediation Service and continued with support from EU Delegation in Albania, UNICEF, Save the Children, OSCE, etc.

As representative of AFCR, Rasim is one of the founders of EFRJ. AFCR, led by him, has been for years an active member of EFRJ since the establishment. The AFCR experience in applying restorative justice at a national level has been introduced in EFRJ conferences. Rasim has been part of the steering group for the project "Building Social Support for Restorative Justice (December 2007-March 2010), implemented by EFRJ.

Comments made by proposer:

Rasim Gjoka's long-term experiences of implementing and developing restorative approaches in Albania – from the transmission times in the 1990s, working at the community level, to building good relations with the justice sector, resulting in agreements and guidelines for cooperation and new legislation, represents accumulation of experiences to promote and implement RJ. Further, Gjoka's vast experience of sharing knowledge in this field both in the Balkan region and in several international and bilateral projects and activities gives him a broad insight into practices and challenges in this field beyond the borders of Albania.

AFCR is one of the oldest and one of the bravest organisations for restorative approaches in Europe in view of the conflicts they have approached, e.g. vendettas in the local communities. The democracy-building aspect to AFCR's engagement promoting peaceful – including restorative – approaches, in times of uncertainty and latent instability of their country in the transmission times, is of great relevance, also for current challenges in Europe for building or maintaining peaceful communities. Rasim Gjoka's central role as the executive director of AFCR from the very beginning gives him a unique experience that would be an asset to the work of the EFRJ board.
