Introduction

In October 2018, the Council of Europe adopted the most advanced international legal instrument in the field of restorative justice: the Recommendation concerning restorative justice in criminal matters, based on the revision of the previous Recommendation on penal mediation. On the same year, the EFRJ launched the European Restorative Justice Policy Network to support national policymakers in need of advice and assistance to implement such Recommendation.

The Recommendation is very progressive because it advocates for the use of restorative justice in all stages of criminal procedures and in all types of crimes. This raises endless possibilities and challenges at the same time, and we need to ask important questions and share our experience on both. Are our standards of practice up the best level? What kind of training do restorative justice facilitators need? What kind of training do judicial agencies need? How can we enhance cooperation between judicial agencies and restorative justice agencies? How to increase access to restorative justice and how to provide information and offer this service? How to encourage restorative justice in specific settings, like in prisons and in juvenile justice cases? In how far can restorative justice empower the parties participating in its practices?

In order to create a platform for exchange, the EFRJ together with our local organizers, the Ministry of Labour and Justice of the Basque Government and Deusto University, organises this international symposium where the restorative community is offered the opportunity to reflect on these important advancements in the field and prepare in terms of policy and practice developments.

Central to our symposium will be the focus on the transition of policy and practice from a more narrow conception of "penal mediation" towards a full-fledged "restorative justice" in criminal (youth) justice systems. We will engage with the Recommendation both as a normative document which shows the way, but also as a document that points both towards possibilities and limitations in the field. Most importantly, we would like to enable practitioners and policy makers to "give life" to the Recommendation, by working together and gaining inspiration from others in the field.

The focus of the symposium will be on sharing good practices, reflections, but also concerns on three central themes:

1) Restorative justice unlimited?: The application of restorative justice in all the stages of the criminal procedure and for all types of crime

2) Restorative justice in prison: risks and opportunities

3) Restorative justice and empowerment: focus on specific target groups

Plenaries

5 June 10.00-11.00 AUDITORIUM

Plenary I - Restorative justice unlimited?: The application of restorative justice in all the stages of the criminal procedure and for all types of crime

Chair: Tim Chapman – EFRJ Chair, Ulster University, Northern Ireland

The plenary will start with presenting the innovative aspects of the new Council of Europe Recommendation on Restorative Justice in Criminal Matters. **Ian Marder**, Lecturer in Criminology at Maynooth University (Ireland), has studied the implementation of restorative policing, public attitudes towards restorative policing and the impact of sentencing guidelines. In 2017/18, he acted as Scientific



Expert for the Council of Europe, with whom he drafted the new Recommendation on restorative justice. Ian will reflect on the move from penal mediation to RJ and present his current work seeking to stimulate the implementation of the Recommendation.



The next presentation will be about the Basque experience of transition from victim-offender-mediation (VOM) services to RJ services in terms of practices, training, policies, protocols. Alberto Olalde is a Lecturer of Social Work at the University of the Basque Country. He has worked as a family mediator and restorative justice facilitator for the Basque Government

(2003-2011): most of his experience is as facilitator in restorative encounters in terrorisms and sexual victimization and as trainer and supervisor with practitioners and researchers. **Nacho Martínez** is the

Coordinator of the Service of Restorative Justice of the Basque Government: he will introduce the implementation work of the Service of Restorative Justice and new restorative practices in the intra-judicial sphere, in cooperation and collaboration with legal operators in the Basque Country.





Finally, the session will end with the policy

developments in The Netherlands regarding the new law proposal on RJ and its effects at the national level. **Theo de Roos**, Emeritus Professor in Criminal Law and Criminal Procedure at Tilburg University (The Netherlands) and chair of Restorative Justice Nederland and former judge in the Court of Appeal Den Bosch until May 2018. Theo will present the contents of and debates about the initiative bill for new provisions in the Dutch legislation for a restorative law, as he was one of the authors of this document.

Plenary II - Restorative justice and empowerment: focus on specific target groups

Chair: Katerina Soulou – EFRJ Board, Aix-Marseille University, France

This panel will focus on the application of RJ for all types of crimes, especially to those cases that create more resistance and debate. The first presentation will focus on sexual violence cases. **Karin Sten Madsen**, independent consultant in Denmark, introduced restorative approaches at the Centre for Victims of Sexual Assault in Copenhagen in 2002 and has since been engaged in various projects on developing and appropriating restorative practice for victims of sexual violence. She



will focus on how to empower victims of sexual violence on every step through a restorative process.



Next, **Bernd Glaeser** will talk about the Austrian discussion on victim-offender-mediation (VOM) and good practice recommendations in cases of intimate partnership violence. He is responsible for VOM and some more services at NEUSTART, the NGO which delivers various probation and mediation services in Austria in cooperation with the Ministry of Justice. He has worked with VOM cases himself, many of them cases of intimate partnership violence before shifting into his current management position.

Finally, the plenary will end with the potentials of RJ encounters in cases of political violence and terrorism. **Diletta Stendardi** took part in the Italian experience told in "The book of the encounter: victims and former armed fighters facing each other" (II Saggiatore, 2015), which narrates the 7-years long journey of encounters between some

ex-members of the armed struggle (Red Brigades and other armed groups) and some victims of the so-called 'years of lead' in the 1970-1980s Italy. Diletta is a criminal lawyer in Milan; member of Supervisory Committees appointed by companies to prevent corporate crimes; registered Lecturer and Trainer for the General Direction of Education of the Ministry of Justice; Lecturer in seminars on RJ and on Penitentiary Law at Università Cattolica del Sacro Cuore di Milano, where she also works on projects and publications for the development of RJ.



Plenary III – Restorative justice, prison and probation: risks and opportunities

Chair: Aarne Kinnunen – EFRJ Board, Ministry of Justice, Finland

present in most European countries.

This panel will focus on the application of RJ in all the stages of the criminal justice procedure. It will start with a presentation on the Basque restorative justice model for the penitentiary system by Jesús Guerrero and Jorge Ollero. Jesús María Guerrero Getxo is a civil servant (psychologist) in the Ministry of Internal Affairs and Spanish General Secretary of Penitentiary Institutions (SGIP), developing specific intervention programs since 1996, including restorative justice. Jesús is also a Lecturer in the practice module of the Social Intervention Psychology Post Degree at Deusto University and he is involved as an expert in several EU twinning projects on prison, probation, drugs and organized crime, and terrorism and radicalision. Jorge Ollero is the coordinator of RJ services at Federación Andaluza ENLACE and former Jurist of Penitentiary Institutions in the Spanish Ministry of Interior. He will propose that restorative interventions in prison should be considered under a critical eye, not forgetting the need to reduce the high rates of incarceration







Ursula Fernee will present the Irish experience on probation, RJ and victims support. Ursula is an Assistant Principal Probation Officer who has worked in a range of operational and developmental roles in the Irish Probation Service. In November 2017, the EU/Directive/2012 was transposed in to Irish Legislation Criminal Justice (Victims of Crime) Act 2017. In 2018, building on a number of existing initiatives, the Probation Service put in place the "Restorative Justice and Victim Services Unit" with Ursula as the national lead. In her presentation, Ursula will look at the development of RJ within the Irish criminal justice system,

the integration of RJ into probation practice, engagement with victims and victim advocacy groups, the current opportunities and challenges and those that lie ahead. The final presentation will refer to the comprehensive RJ law and practice experience in

Belgium, which applies RJ in all type of offences and in any stage of the criminal procedure.

Antonio Buonatesta is the director of the Wallonian RJ service Mediante, senior mediator and trainer and the driving force behind the legislation on victim-offender-mediation in Belgium. Antonio will focus on the established cooperation with criminal justice authorities, including prison and probation services. Referring to the newly adopted Council of Europe Recommendation, he will share important lessons interesting for future organisations and countries that are currently working on the implementation of RJ practices in criminal matters.



Parallel dialogue sessions

These dialogue sessions aim at encouraging interactions and at learning from participants by collecting ideas and recommendations on the topics proposed.

1. Values and standards for restorative justice room 201

facilitated by Tim Chapman and Aarne Kinnunen

This session emphasises the importance of values and standards for assuring quality in restorative justice practices. Attention will be given to how to deal with the tendency of the system to intrude and dominate the restorative space.

2. Different practice models room 202

facilitated by Lars Otto Justad and Patrizia Patrizi This session will focus on different practice models, i.e. mediation, conferencing and circles, with the aim to look at how to expand available services (mostly on mediation) to other restorative practices.

3. Access to restorative justice and victims' participation room 203

facilitated by Bart Claes and Antonio Buonatesta

This session will focus on the type of information given to victims and offenders to propose a restorative justice process, but also on the timing, frequency, and source of the offer made. Attention is mostly given to the general offer of restorative justice and the specific participation of victims, but also to the possibility for self-referrals.

4. Restorative justice for children and adolescents room 204

facilitated by Annemieke Wolthuis and Belinda Hopkins This session will look at practices to encourage children and adolescents to engage in a restorative justice process, focusing on the type of language to be used and the safeguards to protect their vulnerabilities.

5. Cooperating with criminal justice authorities room 207B

facilitated by Nacho Martinez and Ian Marder

This session will focus on the problematic of lack of awareness or understanding about restorative justice within criminal justice professionals and the importance of this for referring cases to the restorative justice services.

6. Training of restorative justice facilitators room A301

facilitated by Alberto Olalde and Karin Madsen

This session focuses on different training models for facilitators in victimoffender mediation, conferences and circles, looking at what exercises and practices are helpful to gain confidence and experience for the field.

7. Support and supervision of restorative justice facilitators

facilitated by Jorge Ollero and Gert Jan Slump This session will focus on existing models for supporting and supervising facilitators before, during and after a restorative justice encounter takes place, looking also at practices for following up cases once the process is over.

8. Databases of restorative justice services room A₃₀₄

facilitated by Katerina Soulou & Fernanda Fonseca Rosenblatt This session will focus on quantitative and qualitative data collection of restorative justice cases, helpful to evaluate, compare and improve services and specific programmes.

The restorative justice encounter / El encuentro de justicia restaurativa room A305

This session wishes to create the space for sharing the experience on the use of RJ in juvenile justice settings in the Basque Country and for sharing feedback and proposals for future projects.

Interactive session I

This sessions will start with a small introduction to the topic in the auditorium. Participants will then be divided in small discussion groups (see page 31) that will report to the plenary at the end of the session. Two facilitators are assigned per each room, one English speaking and one bilingual, so that the discussion groups can take place either in English or Spanish.

Prison talks on restorative justice: from practice to reflection



This session will be facilitated by **Bart Claes**, lecturer on forensic care, restorative justice and prison studies at the Avans University of Applied Sciences (The Netherlands) and Treasurer of the EFRJ Board. Bart also worked as a victim-offender mediator in Belgian prisons and juvenile detention centers and for his PhD he did an ethnographic research on RJ practices in a Belgian maximum security prison. Bart will present on his personal experiences and

daily life in Belgian prisons, including the different relationships prisons entail (e.g. between prisoners and families, between prisons and neighbourhoods) and the role of RJ in this, as well the links between the RJ philosophy and the prison culture.

Interactive session II

6 June 14.00-15.30 AUDITORIUM

Access to RJ for young people

This session will be facilitated by **Annemieke Wolthuis** and **Brunilda Pali**. Annemieke, vice-chair of the EFRJ, is an independent researcher, trainer and mediator in the field of human rights, children's rights and restorative justice in The Netherlands. Brunilda is currently doing her post-PhD research at the KU Leuven Institute of Criminology; among others, she was involved in a EU-funded project on the use of RJ with child victims. Annemieke will present on international legislation relevant for RJ and children rights, while Brunilda will introduce research on the use of RJ with children, particularly child victims.

City of Helsinki using work compensation in mediation

– Juhani Ala-Kurikka, Coordinator, City of Helsinki, Finland

The City of Helsinki has made a policy to refer all crimes to mediation where Helsinki is a plaintiff and the suspect is a minor. To promote equality and empowerment Helsinki offers these suspects a possibility for work compensation. This poster presents the effects and methods of work compensation.

Restorative Justice development perspectives in Georgia

— Mikheil Gabunia, Associate Professor, Georgian Technical University, Georgia

In Georgia, the Diversion and Mediation Program is successfully operating since 15 November 2010. In 2017, 910 people were diverted: mediation was used with 334 offenders and 267 mediation meetings were conducted. From 2010 to 2017, 2733 people younger than 21 were diverted. The statistics on repeated offences are very low (9%). Because of this effective crime prevention, it is advisable to have changes in the Criminal Law of European countries reflecting that misdemeanors and violations should be addressed only by the institution of Diversion and Mediation. In Georgia prosecutors will be able to divert a juvenile not only for minor but also for serious offences.

Intrajudicial mediation experiences in criminal matters

 María del Rocío Gómez Hermoso, Colegio Oficial de Psicólogos de Madrid, Institución de Mediación, Spain

A RJ model is being implemented through a programme consisting of a criminal mediation service offered by trained psychologists. The programme has been carried out since September 2016 in the Provincial Criminal Courts of Alcala de Henares, and since June 2017 in the Local Criminal Courts of Instruction of Madrid. The aims of the programme are to promote and raise awareness about the positive effects of the implementation of mediation practices and victim compensation; to prevent victimisation; to ensure the social and educational character of the sentences by falling on the responsibility of the accused, and to approach justice to citizens bringing their attention to ADRs.

Police mediation as a social purpose within the framework of restorative justice

Helena Pérez Beltrán, Associate Professor at the University Jaume I, Spain

This poster exposes the social utility resulting from the application of conflict resolution methods, and specifically those of police mediation, and its incardination in RJ principles and values. Since 2004, the city of Vila-real successfully developed a police mediation unit, which is today a reference for the citizens of the municipality. In the beginning, schools were the most frequent areas of intervention, while in the last six years, many cases are referred by the Courts of First Instance and Instruction. Police mediation is seen as an adequate way for the parties to find, directly through dialogue, a response that satisfies their most intimate interests, while socially reinforcing norms related to the culture of peace. The experience of Vila-real is serving as an example in other parts of Spain and Latin America for the police to be formed and involved in the building of security, and therefore, peace, so that this new philosophy impregnates in all police procedures.

Damage compensation to victims of sexual violence in armed conflicts. Case study

 Ena Kazic and Rialda Corovic, International University of Sarajevo, Bosnia and Herzegovina

Damage compensation will not erase the critical event, but it can play an important role in the recovery process of victims. The poster presents cases of sexual violence and victims damage claims in Bosnia and Herzegovina, identifying the main challenges in the damage compensation process. After introducing the legal framework that refers to victims' damage claim, participants are invited to identify problems and challenges in the verdict implementation process and contribute in making de lege ferenda recommendations for this country.

The restorative perspective in Spain and its "application" in gender-based violence

 Laura Serramià Balaguer, PhD student at Public Law Department, University of Lleida, Spain

This poster focuses on the current Spanish regulation on RJ and the prohibition of mediation in gender-based violence crimes, discussing the legal problems and the effectiveness of RJ. It also points out some comparative restorative experiences regarding serious crimes, with particular attention to gender-based violence crimes and the Catalan scientific practice.

Almost 2.1 million children in Europe have at least one parent in prison. Imprisonment has an enormous impact on these children and it makes it almost impossible to fulfill the role as a father or mother. In 2018, new European Recommendations focus on working restoratively with these children and imprisoned parents. Restorative principles and practices will be exchanged and discussed in this meeting. In this meeting K.I.N.D, the Dutch Centre of Expertise on children of imprisoned parents, will present a brief conceptual framework as starting point to exchange and discuss restorative principles and practices with the participants.

2. Restorative cities: a challenge for the future room 202

This meeting aims at sharing knowledge and discussing best practices about projects on the implementation of a restorative city. The focus is on founding practices for promoting a restorative city and on the role of emotions and values in the implementation of restorative dialogue at different levels, from supranational regulation to restorative cities.

3. Restorative justice to prevent and respond to violent extremism room 203

— Rasim Gjoka, Director, Albanian Foundation for Conflict Resolution, Albania

— Graziella Fourez, PhD researcher at University Saint-Louis-Brussels, Belgium

This meeting will focus on good practices for preventing violent extremism and radicalisation, such as education measures in schools and communities and potential application of restorative practices, and on RJ in response to the needs of direct and indirect (vicarious) victims of terrorism and its impact on the dissolution of the social link, while focusing on the specificities of terrorism victimisation and its broader psychological and social impact.

- 4. Building sustainable restorative justice programs from law to practice room 204
- Emilie Matignon, Project manager Research and training, France
- Gert Jan Slump, Program Leader / Co-Founder of RJN, The Netherlands

This meeting will focus on access to RJ services, focusing on the implementation of RJ programs (i.e. the French experience in RJ training, partnerships, programs design and assessment, cooperation with victim's support and probation) and on the making of a law for RJ (i.e. the Dutch experience on the new RJ policy initiatives, contents of the law, lesson learned, dialogue on innovation and strategies for change). The models presented are from the IFJR (Institut Français pour la Justice Restaurative), which created regional branches and local services in different parts of France, and RJN (Restorative Justice Nederlands), which initiated a systemic model for regulating and implementing RJ in all The Netherlands.

- 5. Organising restorative justice services and the role of the facilitator room 207B

This meeting will explore good practices and key challenges for ensuring access to good quality RJ services, i.e. on implementation of RJ programs and effective facilitation of RJ processes. How to cooperate and even replace the formal justice? What are the key ingredients of successful facilitation? How can facilitators empower participants to express themselves freely? How can facilitators maximise the emotional dynamics of conferencing and generate 'turning-points'? What are the roles of agency and accountability? How can facilitators remain neutral and non-dominant whilst also making supportive interventions when necessary?

- 1. Using Motivational Interviewing to prepare people for restorative justice room A₃₀₄
- Paul Delaney, Coordinator Cornmarket Project Ireland

What techniques can we use to best prepare people to engage in RJ? We know that in relation to using RJ interventions with offenders, victims and others, that proper preparation of all parties prior to the RJ intervention/conference/meeting is crucial. Experience has shown that a lack of motivation on behalf of participants can undermine the process. This workshop will give attendees practical ideas on how to enhance the likelihood of participant engagement in RJ through using the strategies of Motivational Interviewing, exploring effective strategies for dealing with resistance in the preparatory phase of RJ.

- 2. Finding homes: Rental contracts based on values for refugees families / Encontrar casas: contratos de alquiler basados en valores para familias de refugiados room A305

Refugee families are struggling to find homes in Vitoria-Gasteiz. Despite of many empty houses, many lessors are not confident to rent their houses for different reasons. Our proposal is to implement Rental Conscious contracts[®], based on values and trust. According to their creators, legal documents should reflect your integrity by aligning purpose and values and to prevent conflict. The ADCE (Asociacion de Derecho Colaborativo de Euskadi) is training to implement them since 2017 and some ADCE members, Arteale Foundation and ACCEM, are developing a pilot project using Conscious contracts[®] as an instrument to find new homes for refugee families in Vitoria-Gasteiz. This is a practical workshop exploring how language and cultural differences are managed with comic contracts and parties work with empathy and compassion.

3. Restorative circles for youth with violent behaviour / *Círculos restaurativos para jóvenes con conductas violentas* room A308

- Olga Rodriguez Ochoa, Manager of Day Care Service "Beinke" and the Residential Care Service "Beinketexe", Spain
- Ángel Estalayo Hernández, Technical Manager of the IRSE-EBI, Spain

This workshop focuses on the case of a young adolescent with a borderline personality, with unstable interpersonal relationships and violent behavior to herself and to others. Much attention is given to the educational-therapeutic itinerary done with her and the approach to violent behavior based on the model of Validation Emotional Bonding and incorporating aspects of RJ (i.e. an adaptation of the restorative circles to intervene in this context). After several months of work from this perspective there is evidence of a remission of violent behavior and a greater awareness of dysfunctional patterns, as well as the emotional impact it generates on others. This methodology is relevant for those ones working with young people experiencing behavior problems, violence, drug abuse and mental disorders.

Restorative justice and prison/post-prison higher education

— Alan Mobley, Professor, San Diego State University, California

This presentation focuses on RJ & college degree programs for incarcerated and formerly incarcerated people, including trauma informed social/emotional learning and (social) entrepreneurship course elements. In California, Project Rebound has expanded to ten state university campuses offering services to incarcerated and formerly incarcerated students. The RJ ethos is a key element of the PR model for including the excluded in higher educational offerings.

Restorative dialogues: responsibility taking and reparation as an alternative

- Francisca Lozano, Proyects Coordinator, Asociación de Mediación para la Pacificación de Conflictos, Spain
- Marisol Real, Prison Fellowship Spain, CONCAES, Spain

"Restorative Dialogues. Responsibility taking and reparation as an alternative to imprisonment" is a project dedicated to RJ developed years ago by a number of entities in Spain. Through the participation in this program, people condemned reflect about their own crime, its impact, the damage caused and the ways of repairing it. Indirect victims are invited to participate and to be heard.

Possibilities and challenges with the new penal reactions for youth in Norway

- Frøydis Heyerdahl, Senior Adviser at Konfliktraadet, Norway
- Lars Otto Justad, Senior Adviser at Konfliktraadet, Norway

This presentation includes thoughts and dialogue on the two new penal reactions for young offenders based on restorative principles with the aim to avoid

imprisonment for young offenders. Does it work according to the intentions? What are the challenges and possibilities? The new penal reactions for young offenders were introduced in Norway in 2014. Presenters will give a brief introduction on the contents of the penal reactions, public debates and experiences from the field and then open up for dialogue.

Presentations II room A302

RJ when there is no victim: implications for practice and theory

- Fernanda Fonseca Rosenblatt, Assistant Professor, International Institute for Restorative Practices, Brazil
- Marina Rodrigues de Brito Alves, student, Catholic University of Pernambuco, Brazil

RJ practices should ideally involve 'live' meetings between all affected parties. On the ground, however, many offences lack identifiable victims, some victims do not wish to participate in any way in the process, etc. This presentation is aimed at discussing what has been done and what else can be done, restoratively, in the victim's absence. Participants are invited to share their practical and theoretical experiences, as well as engage in a critical discussion on how to remain committed to the principles underpinning RJ processes, outcomes and objectives, even when there is no encounter.

The split between expel and restore - the foreign national in prison

— Jojanneke van der Molen, Projectleader Restorative Justice, The Netherlands

How to practice RJ with foreigners in prison? If there is no perspective, how can they recover? A special prison in the north of the Netherlands houses over 400 foreigners in prison. This means more than 60 different languages, different cultures and traditions. After imprisonment they will be deported to the country of origin. This situation is a big challenge when thinking of a restorative approach. What works and what can we learn from other countries? Everyone is invited to share experiences and join a dynamic discussion.

Among other activities, the EFRJ supports its members in developing RJ across Europe and beyond by building cooperation, publishing research findings, sharing information and knowledge, organising seminars, conferences, summer schools and events, also on the occasion of the international RJ Weeks. The EFRJ is a membership organisation with about 400 individual and organisational members across Europe and beyond. Since 2012 it is part of the Criminal Justice Platform Europe, a partnership of three well-established network organisations committed to address criminal justice issues in Europe, working in the fields of prison, probation and RJ. www.euforumrj.org

Instituto de Reintegración Social de Euskadi (IRSE)

IRSE is an organization that works in the social sphere with a restorative approach since 1987, providing a number of services and public programmes in the Autonomous Community of the Basque Country. Since 1991 it manages the Basque Government's service of victim support, being pioneers in the whole state. Besides, they have been working on creating education alternatives to help young people in situation of exclusion or vulnerability. In 2009, the Basque Government declared IRSE-EBI as a collaborating Entity regarding the socio-educational care of under-age offenders in the Autonomous Community of the Basque Country. They are currently working in 17 programmes. In 2011 they began to manage the Basque Government's Probation Service, which among others integrates the Gakoa programme for the rehabilitation of men convicted for gender violence. Since June 2016 IRSE-EBI is part of the European Forum of Restorative Justice, actively taking part in its conferences and summer schools. In June 2017 they signed a collaboration agreement with the APAV. In the framework of said collaboration, they take part in the PRO-VICTIMS European Project. Finally, since September 2018 IRSE manages the Basque Government's Restorative Justice Service, which would be the first RJ service in the intra-judicial environment in the adult sphere. www.irse-ebi.org

Asociación de Derecho Colaborativo de Euskadi (ADCE)

ADCE promotes Collaborative Law, Conscious Contracts and collaborative negotiation in order to improve relationships and organizations. From its start, the Basque Government and Basque Parliament have supported this Association. 20.30-22.00 La Mirada del Otro



Ad-hoc meeting of the European RJ Policy Network




